The following business was transacted:

A check in the amount of \$343.32 was received by the county from the Waccamaw Bank & Trust Company, Whiteville, N. C., in the estate of Vermell J. Rushing to apply on OAA Lien held by county. However, this does not pay lien in full and same should not be cancelled. For further information concerning this OAA Lien see page 694.

Mr. Bob Carroll, a member of the Harwood Beebe Company, Spartanburg, S. C., who is consulting engineers, appeared before the Board to discuss the first step of a comprehensive study of sewer and water in Columbus County. Several members of the Columbus County Planning Committee was also present along with Mr. Hugh Clark representing FHA. A study of the report presented will be made by the Planning Committee, County Commissioners, and FHA board and action will be taken at the November 20th meeting to decide to accept or reject the proposals of the engineers thus far.

Ordered: that Southeastern Community College be granted permission to use voting machine from Whiteville in their election on October 30, 1967.

Ordered: that Leo Fisher, Register of Deeds, be granted permission to order an Excise Stamp Tax machine in the amount of \$666.00 which will levy conveyances on real estate.

Ordered: that the Whiteville Merchants Association be given a check in the amount of \$427.72 for Christmas street decorations for the year 1967. The Board of County Commissioners and the Merchants Association agreed that these decorations will be used for courthouse use only. This is a three year agreement with payments of \$400 in the year 1968 and \$400 in the year 1969 with no interest charged. At the end of the three years, the decorations will become county property.

Ordered: that poll tax listed in the name of D. F. Jones, Lees Township, be cancelled for the years 1964 and 1965. Mr. Jones was in service during these two years.

Ordered: that personal property valuation listed in the name of Mabel W. Bradley, Tatum Township, be reduced in the amount of \$630.00 for the year 1967 due to error in listing automobile.

Ordered: that personal property valuation listed in the name of Allen Dale Watts, South Williams Township, be reduced in the amount of \$1,555.00 for the year 1967 due to error in listing house trailer.
