The following business was transacted:

The minutes of the February 2nd meeting were read and approved.

Ordered: that a check in the amount of \$25 be written from the Out Door Poor Fund to NewMetal Smith, Route 1, Nakina, N..C.

Mr. David W. Alexander, Executive Director of Southeastern Economic Development Commission, appeared before the Board and discussed various Federal assistance programs now available to county governments through grants and long term loans. Informative slides were also shown.

Ordered: that a ^{tax} refund for the year 1968 in Whiteville Township be made to X. Brown and Frank Gross due to a lot being double listed. Tax valuation of lot \$7630.

Ordered: that a tax refund for the years 1968 and 1969 be made to Mr. Arthur Fowler, South Williams Township, due to error in listing lot. Corrected valuation should read \$7510. Refund due on \$2880 valuation.

Ordered: the following tax release based on recommendation from Tax Supervisor's Office.

Ordered: that the valuation of the property listed in the name of X. Brown and Frank Gross, Whiteville Township, be reduced in the amount of \$7630 for the year 1969 due to double listing. The property is also listed to Jack H. Benbow and Albert Lee Splawn.

ROAD PETITION: SOUTH WILLIAMS TOWNSHIP: This road SR # 1129 is located off Highway # 904 to # 701 on right from Harvey Powell's Service Station. It is 1 mile in length and has 8 occupied homes located on it.


RANSOM TOWNSHIP: Road # SR 1842 known as Carolina Avenue. Road is 1 mile in length and has 11 occupied homes located on it.
