class and shortly thereafter attended her first Association of Retarded Citizens meeting in Columbus County; and

WHEREAS, Mavis Carroll has actively participated in the Columbus County Association of Retarded Citizens organization by serving on all levels, including its presidency for many years, and has collected money from various organizations, churches, governmental bodies, and civic clubs for the support of the organiza-

tion; and

WHEREAS, Mavis Carroll was instrumental in the formation of a group home for the retarded citizens of Columbus County; and

WHEREAS, Mavis Carroll was selected as the North Carolina Volunteer of the year in 1977; and

WHEREAS, Mavis Carroll was selected by the Honorable James B. Hunt, Jr., Governor of the State of North Carolina, in 1978 as the Disable Volunteer of the Year; and

WHEREAS, the North Carolina Association of Retarded Citizens selected Mavis Carroll as their first State Parent of the Year in 1982; and

WHEREAS, Elrod Carroll has always supported Mavis Carroll's promotion of retarded citizens causes; and

WHEREAS, Mavis Carroll has suffered a stroke and has been diagnosed as suffering from congestive heart failure, sugar diabetes and hypertension; and
