A motion was made by Commissioner Koonce, seconded by Commissioner Norris and passed unanimously to adjourn into executive session to discuss personnel.


**RESUME REGULAR SESSION**



SHERIFF DEPT. - CONTRACT TO PROVIDE POLICE PROTECTION FOR CERRO GORDO
