## R E S O L U T I O N

THAT, WHEREAS, the Town of Fair Bluff has, by resolution dated November 4, 1991, adopted an Extraterritorial Zoning and Subdivision Regulation, pursuant to the provisions of N.C.G.S. 160A-362; and,

WHEREAS, the Town of Fair Bluff has codified the same in the Fair Bluff Town Code, and has prepared a map detailing the one (1) mile radius in which the Extraterritorial Zoning of Subdivision Regulations will apply; and

WHEREAS, the Town of Fair Bluff has requested that the County of Columbus authorize and grant the Town of Fair Bluff to exercise the Extraterritorial zoning and regulatory powers within the Extraterritorial Zoning Area as reflected on the map prepared for the Town of Fair Bluff; and

WHEREAS, the County of Columbus is willing to extend said Extraterritorial Zoning Subdivision regulatory powers to the Town of Fair Bluff, pursuant to the provisions of N.C.G.S. Chapter 160A.

NOW, THEREFORE, BE IT RESOLVED upon motion of Commissioner Samuel G. Koonce, seconded by Commissioner Junior Dew, that the County of Columbus hereby extends, authorizes and grants unto the Town of Fair Bluff, pursuant to the provisions of N.C.G.S. Chapter 160A, the power, authority and right to regulate, govern, administer, enforce and take all actions necessary to assure compliance of

the Extraterritorial Jurisdiction Zoning and Subdivision Regulations heretofore adopted by the Town of Fair Bluff.

This Resolution shall become effective upon its adoption, this the 18th day of November, 1991.
