MEETING ADJOURNED

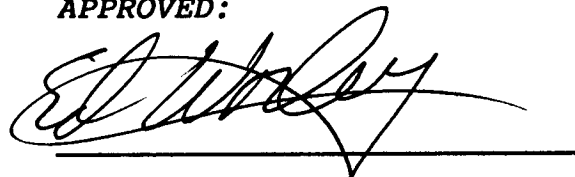
A motion was made by Commissioner Norris, seconded by Commissioner Richardson and passed unanimously to adjourn the meeting at 9:15 P.M.
