RESOLUTION - SUPPORT OF PROPOSED STATE OF N.C. BOND ISSUES

Dr. Steve Scott, President of Southeastern Community College, requested the Board's endorsement on the proposed State of North Carolina Bond Issues that will authorize the issuance of \$740 million dollars in general obligation bonds of the State, if approved by the voters in a referendum to be held Tuesday, November 2, 1993.

A motion was made by Commissioner Norris, seconded by Commissioner Williams and passed unanimously to adopt the following Resolution supporting the proposed State of N.C. Bond Issues.

RESOLUTION IN SUPPORT OF THE COMMUNITY

COLLEGES BOND ISSUE ON

NOVEMBER 2, 1993

WHEREAS, *North Carolina's community colleges have been accessible to all citizens of this state and have provided the state's competitive edge for economic and educational progress; and*

WHEREAS, *North Carolina's community colleges serve a higher percentage of the state's constituent population than does any other community college system in the country and serves as a model for the nation; and*

WHEREAS, *for the past three decades, North Carolina's community colleges have proven to be an invaluable tool in economic development and the good quality of life we enjoy; and*

WHEREAS, North Carolina's community colleges have demonstrated in several instances their ability to change lives by helping people to learn to read and write, complete high school, learn new skills, upgrade existing skills, and transfer to four-year colleges and universities; and

WHEREAS, North Carolina community colleges have filled their critical economic and educational roles efficiently and effectively; and

WHEREAS, North Carolina's community colleges often operate in cramped facilities with outdated equipment; and

WHEREAS, the time is ideal for the State to borrow long-term funds to finance the construction of much-needed buildings, thereby easing the burden on local governments, which traditionally have had the responsibility for building community college facilities; and

WHEREAS, the Columbus County Board of Commissioners believes it is in the best interest of the citizens of Columbus County that Southeastern Community College benefits from the statewide bond issue that would finance new buildings on our campus and every other community college campus in North Carolina; it is hereby

RESOLVED that the Columbus County Board of Commissioners offers its endorsement of the bond referendum for the North Carolina Community College System, including Southeastern Community College, and urges all citizens in this area to support this issue by voting **FOR** the community college bonds on November 2, 1993.

ECONOMIC DEVELOPMENT - ONE MILLION DOLLARS AWARDED TO COLUMBUS COUNTY BY THE N. C. GENERAL ASSEMBLY

R. C. Soles, Jr., Senator, presented to the Board of Columbus County Commissioners a check for one million dollars to be used for Economic Development infrastructure in Columbus County.

Also, present for the presentation were Representatives Dewey Hill, David Redwine and Thomas Wright.

Chairman Koonce thanked members of the General Assembly, representing Columbus County, for their invaluable help in securing the million dollar appropriation from the State of North Carolina.

BUILDINGS (SOCIAL SERVICES) - WHITEVILLE DOWNTOWN DEVELOPMENT COMMISSION

Richard Wright, a concerned citizen, representing the Whiteville Downtown Development Commission, presented an alternative package for the construction of the Social Services Building that is scheduled to be built on County-owned property located on 701 North of Whiteville. The proposal would include an equal amount of office space in three existing buildings at the Lewis Smith Shopping Center at an estimated cost of \$1.9 million dollars. The group estimated it would take \$1.3 million to renovate areas now occupied by Whiteville Carpet and Tile, Jones Store and Allied Department Store.

Chairman Koonce advised the Whiteville Downtown Development Commission that the Board has already heard two other proposals on downtown locations, that were not acceptable by the state and the present project is almost ready to seek bids for water and sewer construction at the new site.

A motion was made by Commissioner Norris, seconded by Commissioner Jacobs and passed unanimously to accept the proposal and take under advisement and contact Sarah Delancey, Department of Human Resources Regional Director, and request her comments on the proposal.

CONTRACT - SOCIAL SERVICES EMPLOYMENT OF SECONDARY ATTORNEY

A motion was made by Commissioner Richardson, seconded by Commissioner Williams and passed unanimously to approve the following Contract of Employment for a Secondary Attorney with the Department of Social Services.

CONTRACT OF SECONDARY EMPLOYMENT**(Secondary Attorney)**

STATE OF NORTH CAROLINA

COUNTY OF COLUMBUS

THIS CONTRACT OF SECONDARY EMPLOYMENT, by and between the Columbus County Commissioners (hereinafter referred to as Department), and Davis S. Tedder, Attorney-At-Law (hereinafter referred to as Attorney), to provide for the legal services needed by the Columbus County Child Support Agency (hereinafter referred to as Agency).

W I T N E S S E T H :

WHEREAS, the Department desires to employ the attorney to provide the legal services needed by the Agency upon the following terms:

1. *That this contract shall begin December 1, 1993, and will continue through November 30, 1994, unless terminated, renewed, or extended as provided herein.*

2. *That the Attorney, upon reasonable notice, shall be available for consultation, legal advice and representation as requested by the Agency on legal matters arising under Article 9, Chapter 110 of the North Carolina General Statutes, Title 42 United States Code, Section 651, et seq., and the regulations promulgated thereunder.*

3. *That the Attorney agrees to comply with all the requirements of Article 9, Chapter 100 of the North Carolina General Statutes, Title 42 United States Code, Section 651, et seq., and the regulations promulgated thereunder, regarding the performance of program legal services. These requirements include, but are not limited to, maintaining such records as are required by the Department or Agency, making such records available for federal or state audit, if required, and making any financial, statistical, and program progress reports.*

4. *That the Department agrees to pay the Attorney sixty and 00/100 (\$60.00) dollars per hour for the time spent in performing the services required under this Contract. This hourly rate shall encompass all expenses including, but not limited to, those for salary, supplies, office space, heating and maintenance for office space, telephone service, long-distance telephone calls, and travel. That the Attorney is not to be reimbursed for incurring extraordinary expenses incidental to performing the services required under this Contract, with the exception that the Department agrees to pay all court costs and filing fees which are required to be paid in conjunction with the services provided by the Attorney under this Contract.*

5. *That either party may terminate this Contract with thirty (30) days written notice to the other party.*

6. That it is understood and agreed between the Department and the Attorney that the payment of compensation specified in this Contract, its continuation or any renewal or extension thereof, is dependent upon and subject to, the allocation and appropriation of funds to the Department for the purpose set forth in this Contract.

7. That the Department has the option to renew or extend this Contract for additional one (1) year periods, not to exceed two (2) renewals or extension.

NOW THEREFORE, the parties have executed this Contract in triplicate originals, one (1) to be retained by the Attorney, one (1) to be retained by the Agency and one (1) to be filed with the Child Support Enforcement Section of the Department.

EMERGENCY MANAGEMENT (E-911) - UPDATE

Dempsey Herring, Special Projects Director, updated the Board on the results of two professionals evaluating the Miller Building to be used for the E-911 Center. The report showed that expanding the facility would not be feasible due to the structure and the complete building could be built cheaper than adding on to the existing building which would disallow the use of the E-911 Surcharge. The total renovation of the existing structure (Miller Building Wing) would be more feasible and the E-911 Surcharge can be used for the renovation.

EMERGENCY MANAGEMENT (E-911) - NOTICE OF PUBLIC HEARING

A motion was made by Commissioner Richardson, seconded by Commissioner Norris and passed unanimously to hold a public hearing Monday, November 15, 1993 at 7:30 P.M. for the purpose of receiving public comment concerning a proposal for the County to finance an amount not to exceed \$1,400,000 to acquire and construct central E-911 communications equipment pursuant to an installment financing contract.

ORDINANCE - HEIGHT HAZARD TO LIMIT HEIGHT OF OBJECTS AROUND
COLUMBUS COUNTY AIRPORT RESCINDED

A motion was made by Commissioner Worley, seconded by Commission Williams and passed unanimously to rescind the Columbus County Airport Height Hazard Ordinance to limit the height of objects around the Columbus County Airport until such time a public hearing can be held in accordance with N.C. General Statutes (Chapter 63, Article 4).

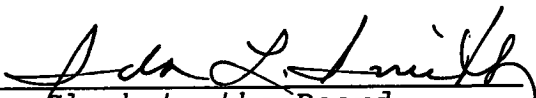
ECONOMIC DEVELOPMENT - DIRECTOR POSITION OFFERED TO STEVEN YOST

A motion was made by Commissioner Gray, seconded by Commissioner Williams and passed unanimously to offer the position as Economic Development Director to Steven Yost, Kinston, North Carolina, at a starting salary not to exceed \$30,000.00, plus fringe benefits.
