Agenda Item #7: EMERGENCY SERVICES - DEPARTMENTAL UPDATE:

Ronnie Hayes, Emergency Services Director, presented the following Departmental Update:

1. Emergencies Services is made up of several different entities;
2. We have a dedicated group of employees which consists of twenty (20) full-time, three (3) part-time and one (1) volunteer;
3. The 911 Communications Center (Columbus Central) has been extremely busy the past year;
4. Columbus Central is the only Public Safety Authorization Point (PSAP) in the county;
5. We have updated the county Hazard Mitigation Plan, as required by FEMA;
6. We have been assisting with the 2004 CHAF Program, the LEPC, County Fire and Rescue Association, Georgia Pacific and International Paper with starting up a County Rope Rescue Team which is greatly needed;
7. Columbus Central, Addressing and the GIS Department changed every ESN (Emergency Service Number) in the county this past year;
8. The Fire Marshal's Office has conducted two hundred thirty-four (234) fire inspections during 2005;
9. During 2005, staff and I responded to one hundred ninety-six (196) requests for assistance from the counties first responders; **and**
10. I am honored to work with the devoted employees in the county and thank you for your continued support.

Agenda Item #9: LEGAL - APPROVAL and ADOPTION of a TAX FORECLOSURE POLICY:

Steven W. Fowler, Columbus County Attorney, requested Board approval and adoption of the following Tax Foreclosure Policy.

Tax Foreclosure Policy

Whereas, each year, the County of Columbus, through its Commissioners, shall direct its Revenue Collector to collect all taxes due and owing, and shall direct the County Attorney to assist the said Revenue Collector as shall be necessary, it shall be their unfortunate duty to foreclose the tax lien on all parcels where such action is appropriate. It shall be the policy of the County of Columbus to levy as part of the Court costs in all such actions a fee of Two Hundred Fifty Dollars and no/100 (\$250.00) in order to partially recover the County's expenses of its efforts to collect said taxes. Any and all such fees so collected shall be for the use and benefit of the taxing unit, the County of Columbus.

This fee shall attach at the time as the Complaint is tendered to the Clerk of Superior Court for the action of foreclosure, and in no instance thereafter shall said fee be waived.

Adopted in open session of the Columbus County Board of Commissioners on the 17th day of January, 2006, and effective from that date.

- A. I apologize for being late, and I understand the Retirement Plaque has already been presented to Betty Thompson;
- B. I wanted do say that Ms. Thompson was a valuable employee who displayed good work ethics;
- C. We tried very hard to convince Ms. Thompson not to retire, but our efforts were in vain;
- D. Ms. Thompson worked from 1961 to 1971 and left to raise a family, which is ten (10) years in addition to what is showing on the plaque.

RECESS REGULAR SESSION and enter into a JOINT MEETING of COLUMBUS COUNTY WATER and SEWER DISTRICTS I, II, III, IV and V BOARD MEETING:

At 7:03 P.M., Commissioner Memory made a motion to adjourn the joint meeting of Columbus County Water and Sewer Districts I, II, III, IV and V Board Meeting, and resume Regular Session, seconded by Vice Chairman Dutton. The motion unanimously carried.

C. Board of Commissioners:

1. **Vice Chairman David L. Dutton, Jr.:** stated he had two (2) issues to address and they are as follows:

Issue 1: I am requesting that Administration speak to Robert Crumpler about the condition of Sellers Town Road and find out if anything can be done for improvement, and if so, when.

Issue 2: The Manufactured/Mobile Home Park Ordinance:

- A. This ordinance was adopted on May 05, 1997, amended on November 17, 1997, and amended on February 16, 1998;
- B. The purpose of this ordinance was to set standards for mobile home parks to allow access for emergency vehicles;
- C. This ordinance was to be reviewed again and amended once more, but was never done;
- D. The intent of this ordinance was to specify an all-weather road which would meet state specifications, not necessarily a paved road.

In-depth discussion was conducted among the Board members relative to the road language within this ordinance and its intent and purpose.

MOTION: Vice Chairman Dutton made a three (3) part motion;

- (1) To send the Manufactured/Mobile Home Park Ordinance for Columbus County, to the Columbus County Planning Board, for the purpose of amending and updating the language in reference to paved roads, and replace with road development program language;
- (2) Suspend the paved-road portion of the requirement of the Department of Transportation's paved road standard, and use the Board of Adjustments' recommendation; **and**
- (3) To include an all-weather road which will meet State specifications.

This motion was seconded by Commissioner Prevatte and passed unanimously.

2. **Commissioner James Prevatte:** when Administration contacts Robert Crumpler, I would like for them to request he look at Smyrna Road and Red Store Road, in addition to Sellers Town Road.

3. **Commissioner Sammie Jacobs:** I would like Administration to add Old Lake Road to the list

of roads for Mr. Crumpler to look at.

4. **Commissioner Bill Memory:** I am requesting that Ronnie Hayes, Emergency Services Director, get with the Columbus County Planning Board for the purpose of bringing the existing mobile home parks in Columbus County up to standards.
5. **Commissioner Lynwood Norris:** stated the following:
 - A. I have received a letter from Ms. Mary A. Stanley;
 - B. This letter is regarding Sandy Place Drive;
 - C. There are approximately thirty (30) to forty (40) houses on this road;
 - D. Ms. Stanley is asking that Columbus County repair and maintain this road, which we can't do; **and**
 - E. I am requesting the Clerk to the Board send a response letter to Ms. Stanley.
