Agenda Items #1 and #2: MEETING CALLED to ORDER and INVOCATION:

At 6:30 P.M., Chairman Godwin called the meeting to order. The invocation was delivered by Commissioner Bill Memory. Everyone in attendance stood and pledged Allegiance to the Flag of the United States of America, which was led by Vice Chairman David L. Dutton, Jr.

Agenda Item #3: BOARD MINUTES APPROVAL:

Commissioner Jacobs made a motion to approve the October 16, 2006 Regular Session Board Minutes, as recorded, seconded by Commissioner Norris. The motion unanimously carried.

RECESS REGULAR SESSION and enter into COLUMBUS COUNTY WATER and SEWER DISTRICT V BOARD MEETING:

At 6:33 P.M., Commissioner Memory made a motion to recess Regular Session and enter into a Columbus County Water and Sewer District V Board Meeting, seconded by Commissioner Norris. The motion unanimously carried.

ADJOURN COLUMBUS COUNTY WATER and SEWER DISTRICT V BOARD MEETING and resume REGULAR SESSION:

At 6:41 P.M., Commissioner Memory made a motion to adjourn Columbus County Water and Sewer District V Board Meeting, and resume Regular Session, seconded by Commissioner Jacobs. The motion unanimously carried.

Agenda Item #5: PLANNING - APPROVAL and ADOPTION of the COLUMBUS COUNTY COMPREHENSIVE TRANSPORTATION PLAN and RESOLUTION:

Tyler Bray, EIT, North Carolina Department of Transportation, and Stevie Cox, Columbus County Planner, requested Board approval of the Columbus County Comprehensive Transportation Plan and Resolution.

Chairman Godwin stated that a response had not been received from Tyler Bray, EIT, North Carolina Department of Transportation, relative to the interchange at East Columbus High School

and the impact this would have on the Town of Lake Waccamaw.

Commissioner Prevatte stated that the Department of Transportation does not need endorsement on this.

Commissioner Prevatte made a motion to table the approval and adoption of the Columbus County Comprehensive Transportation Plan and Resolution, until a response was received from Tyler Bray addressing the two (2) concerns previously stated. This motion was seconded by Commissioner Norris, and unanimously carried.

Agenda Item #6: ECONOMIC DEVELOPMENT - APPROVAL of INCENTIVE GRANT for FILTEC PRECISE;

Jim Hinkle, Interim Economic Development Director, requested Board approval of an Incentive Grant for the Filtec Precise expansion.

After discussion was conducted relative to the need for a public hearing to be held before this incentive is granted, Commissioner Memory made a motion to table the approval of the incentive grant for Filtec Precise until November 20, 2006, seconded by Commissioner McKenzie. The motion unanimously carried.

Agenda Item #7: SOCIAL SERVICES - APPROVAL of 2007-2008 WORK FIRST PLAN:

Algernon McKenzie, Social Work Supervisor, requested Board approval of the 2007-2008 Work First Plan. Mr. McKenzie stated the following:

1. This plan must be done every two (2) years;
2. The County Commissioners approved the recommended committee members at a previous meeting;
3. This committee met and made recommendations to this plan at two (2) meetings; **and**
4. This plan will be operational starting 2007-2008.

Commissioner McKenzie made a motion to approve the 2007-2008 Work First Plan, as presented, seconded by Commissioner Prevatte. The motion unanimously carried. This document will be kept on file in the Office of the Clerk to the Board, and in the Office of Algernon McKenzie, for review.

Agenda Item #8: AGING - PRESENTATION of REQUEST for a NEW BUILDING at COUNTY COMPLEX:

Ed Worley, Aging Director, requested Board acceptance of expressions and concerns, by six (6) employees, for a new building. Mr. Worley stated the following:

1. Our Aging Department has become the largest in the State of North Carolina, and, also serves as a model for the State;
2. We have two hundred seventy-five (275) staff members and contract workers on hand;
3. We sponsor twenty-eight to thirty (28-30) programs;
4. We have outgrown our space;
5. The seniors in Columbus County have become healthier, and are living longer; **and**
6. Four (4) of my employees would like to address the Board relative to our space needs.

Judy Ward: stated the following:

1. Senior citizens are one of the biggest population in Columbus County;
2. Some of offices are located in areas as small as a closet space;
3. We need three (3) times the amount of space we have now; **and**
4. This department would like to serve our senior citizens better than we have before.

Jean Powers: stated the following:

1. I am very interested in helping the senior citizens of Columbus County;
2. Our exercise room is only a forty foot by twenty-four foot (40' x 24') room housing twenty-seven (27) machines;
3. We had sixty-eight (68) clients exercising in this room today;
4. In order for our senior citizens to stay fit, they need to exercise regularly; **and**

5. Hand to eye coordination is very important for our senior citizens to stay alert.

Margaret Hicks: stated the following:

1. I am eighty-four (84) years old and I concentrate heavily on the preventable factor when it come to a person's health;
2. The exercise program is the most important program at the Aging Department for our senior citizens;
3. There is inadequate space to meet the needs for the senior citizens in Columbus County;
4. I would like to thank Mr. Worley for creating senior centers in the different areas of the county to accommodate those senior citizens who cannot travel long distances;
5. We have one hundred seventy-five to two hundred (175-200) people who exercise daily; **and**
6. We need more space to accommodate the great interest and demand we have in Columbus County.

Elizabeth Motto: stated the following:

1. I concur with all the previous statements that have been made; **and**
2. We truly are jammed and need additional space to offer the needed services for our senior citizens.

Chairman Godwin stated that one (1) Public Comment Card had been filled out by Robert Adams, and he wanted to speak on the same topic of the limited space at the Columbus County Aging Department, and we will allow him to address the Board at this time.

PUBLIC COMMENT:

Robert Adams: stated the following:

1. I wish to thank you for this opportunity to speak;
2. I would like to thank you for pursuing this matter;
3. I am requesting that this Board keep active and locate a new and larger location;
4. The Columbus County Department of Aging has simply outgrown itself for the amount of space they now have; **and**
6. I am requesting the Board to adopt a Resolution to pursue sources of revenue and to a new and larger building.

Commissioner McKenzie asked Mr. Worley if he had a place in mind for the new building. Mr. Worley replied stating we need at least forty thousand (40,000) square feet, and the location at Government Complex Road would be ideal.

Commissioner Memory asked Mr. Worley if he had the money for this expenditure of a new building. Mr. Worley replied he had the money in his budget to make an annual payment on the debt for a new building.

Commissioner Jacobs stated that when the Board purchased the property for the Government Complex, it was purchased with the plans for locating the Department of Aging there, and possibly other County departments. I recommend that we put a committee together to look at the options we may have for this request.

Commissioner Norris stated that the Columbus County Department of Aging deserved, and needed, this additional space, and this department is rendering needed various programs for our senior citizens.

After additional discussion was conducted, it was the general consensus of the Board that after the board re-organizes in December, the Board would appoint a committee comprised of members from the Board of Commissioners, Aging Department, and any other department that was needed to look into this matter.

Agenda Item #9: TAX - DEPARTMENTAL UPDATE:

Richard Gore, Columbus County Tax Administrator, delivered the following Departmental Update to the Board.

1. **Real Estate Transaction History:** in 1998, there were 1,556, and in 2005, there were 2,640;
2. **Parcel County History:** in 1998, there were 36,315, and in 2005, there were 41,370;

3. From the year 1995 through 2006, the number of double-wide homes and mobile homes have increased more than stick-built homes;
4. The Columbus County Land Records are now available on the Columbus County Website;
5. The Property Tax Collections for period beginning July 01, 2006 and ending October 31, 2006 were \$14,909,616.20;
6. The General Fund Levy for 2006 through the month of October, 2006 we \$11,432,580.41;
7. On Real and Personal Property taxes, at the end of 1997, .9947% was collected, and at the present time, in 2006, .5107% has been collected; **and**
8. At the end of 2000, the Vehicle Collections percentage rate was 94.56%, and at the present time in 2006, 53.61%.

Commissioner McKenzie made a motion to approve the establishment of November 20, 2006, at 5:30 P.M., as the date for a Public Hearing to be conducted on a Capacity Building Grant for the DREAM Center, seconded by Commissioner Jacobs. The motion unanimously carried.

Agenda Item #11: LOWER CAPE FEAR WATER and SEWER AUTHORITY - ESTABLISH DATE for PUBLIC HEARING:

Don Betz, Executive Director, Lower Cape Fear Water and Sewer Authority, requested the Board to establish November 20, 2006, at 5:35 P.M., as the date for the required Public Hearing to be held, to increase the representation of Bladen County, from one (1) member to two (2) members, on the Authority's Board.

Commissioner Norris made a motion to establish November 20, 2006, at 5:35 P.M., as the date for the required Public Hearing to be held, to increase the representation of Bladen County, from one (1) member to two (2) members, on the Authority's Board. This motion was seconded by Commissioner Prevatte, and unanimously carried.

Stevie Cox, Columbus County Planner, requested the Board to establish November 20, 2006, at 5:45 P.M., as the date for a Public Hearing to be conducted on the Revised Proposed Columbus County Subdivision Regulations Ordinance.

Commissioner Prevatte stated that there needed to an approval or disapproval by the Planning Board of this revised document, asked the following questions: has the edited form been put on the County website for public review, and what will be the price if anyone chooses to purchase a copy of this document?

Stevie Cox replied stating the revised form has not been placed on the County website, but would be placed on the County website when the Board of Commissioners was ready for the public to review the document. The price for this document will be twenty-five (\$.25) cents per page, or anyone could download the document from the website at no charge.

Vice Chairman Dutton made a motion to table this Agenda Item until the newly elected County Commissioners have been seated on the Board, have been acclimated to the document's contents, and have sufficient time to familiarize themselves with the same, seconded by Commissioner Norris.
