#### Agenda Items #1:

#### **MEETING CALLED to ORDER:**

At 5:00 P.M., Chairman Bullard called the meeting to order.

#### Agenda Item #2: USDA AND THE FUTURE OF COLUMBUS COUNTY:

USDA North Carolina Rural Development State Director Reginald Speight discussed the role of the USDA in the future of Columbus County.

#### Reginald Speight, USDA Rural Development State Director, stated the following:

- -Good evening everyone, I am Reginald Speight, your USDA Rural Development Director and I bring you greetings on behalf of Mr. Tom Vilsack, the Secretary of Agriculture.
- -I would like to introduce some staff who are here with me, Mr. Larry Sampson, who is our area Director, located in our Lumberton office, and Mr. Rob Kerns, our Public Information Officer, who is in our Raleigh Office.
- -Thank you for indulging me this evening, I wanted to come and introduce myself as the new State Director for Rural Development.
- -I'm new to Rural Development but I am not new to rural.
- -I was born in Pitt County and raised in a little town there called Farmville, and from the name alone you can probably tell what I was doing growing up.
- -I'm here this evening to discuss some of Rural Development's Programs and the Infrastructure Bill that was recently passed.
- -I'm going to talk about how it works with Rural Development and discuss some things I'm hopeful we will be able to do here in Columbus County.
- -You may have heard of the terms Persistent Poverty Counties or heard some discussion around it.
- -That is a federal designation, and essentially the definition of a Persistent Poverty County is a county that has 20% or higher poverty rate for the last 30 years.
- -That number is not rounded, if a county fell below that percentage point to 19.8% or 19.9%, then those counties were not counted and are not considered a Persistent Poverty County.
- -As of 2010, there were 10 Persistent Poverty Counties in the state of North Carolina.
- -With the new 2020 Census data, there are now 15 counties that are persistent poverty counties, and Columbus County is one of those counties.
- -So, the reason I said you will be seeing more of me and more of Mr. Sampson is because part of our goal is to have some intentional effort in persistent poverty counties in the state of North Carolina.
- -There are persistent poverty counties throughout the country and in those counties we are finding that there are some census tracks or areas that have not benefitted from rural development investments for the last 5 years.
- -I did an overlay of all of the programs that we operate in Rural Development to see areas where we may not have had any investment for the last 5 years.
- -I won't pretend to know your geography better than you, but when you start talking about areas like Whiteville, Boardman, Evergreen, Nakina and Hallsboro, there have been no investment of Rural Development dollars in those areas since 2016.
- -Our purpose is to change that paradigm through the utilization of the programs that we have within Rural Development.
- -I want to provide a quick overview of the portfolio that we operate and then I will tell you where the infrastructure bill and some of that revenue within the infrastructure bill fits within our portfolio.
- -One of our first portfolios is our Rural Housing Services component and within that we have Single-Family Housing Development, where we can be the bank.

- -So if an individual family, and each individual household would have to qualify, we can be the bank for those individuals who may be marginal and not credit worthy and unable to get a loan through a primary lender.
- -We can be the bank for them.
- -For those individuals who may be a high credit risk, we can do a Single Family Housing Guarantee, where we can guarantee 100% on the backend for the bank to help eliminate closing costs or down payments for those individuals.
- -For individuals who may not be interested in buying or purchasing a new home, we have our single family rehab program, where we can go in, in a loan-grant combination, and we can do rehabilitation to a home, providing up to \$10,000 in grants and up to \$40,000 in loans.
- -Within that same component with rural housing is the piece you may be most familiar with, which is our Community Programs.
- -Our Community Programs is where we build schools, fire departments, police departments, police cars, fire trucks, town halls, community centers, hospitals and clinics.
- -These are the types of things we can do with our Community Facilities Program.
- -Then we have our Rural Business Cooperative Services Component.
- -We do not replace the Small Business Administration, we don't help businesses get started, but if there is a business already established, and they're looking at refinancing some of their debt or expanding their footprint to serve more areas, there are offerings within our Rural Business Cooperative Service Program where we can assist with those things.
- -Lastly, and where the infrastructure bill comes into play within Rural Development is our Rural Utilities Services component.
- -You may have heard about our deployment of broadband, our water and wastewater projects, or telecom projects and other things we have done.
- -We are certain that there will be additional revenue that we will be receiving as part of the infrastructure bill that will come to the Rural Utilities Services component.
- -As you can well imagine, and you don't have to go too far, especially after this pandemic, to understand the importance of broadband.
- -And, it's time for us to recognize the fact that broadband needs to be talked about as electricity.
- -We don't talk about installing plumbing or electricity in a home, so, we need to start thinking about broadband in the same way as part of any new construction; understanding that it has to be affordable, reliable and have adequate speeds.
- -Those are the things that we are going to be working on, that this administration is working on, and as I said you will hear more about additional revenue that is in the infrastructure bill.
- -Of course, you're going to hear about bridges, roads, railways and other things that fall under the traditional understanding of infrastructure, but you're also going to hear about the necessity for clean water, clean water efforts and how it relates to health and health statistics in our community.
- -You'll hear about education and health care; a lot of conversations about distance learning and telemedicine and that is within our portfolio, and broadband is essential for those things to happen.
- -So, I just wanted to stop through, just for a moment, and I'm willing to entertain any questions Mr. Chairman, to introduce myself or reintroduce myself to some and to let you know that as you're moving forward with these conversations with broadband, telehealth, water-sewer, with community projects and single-family housing, please consider rural development to be a tool in your toolbox.
- -Either from a municipality level or for an individual level from families that you're engaging with and you think we can be a resource for you and a partner in your efforts.
- -If you're looking at some of the larger projects, like broadband, water or waste-water, and you're thinking that you want Rural Development to be at the table with you, talk to us early.
- -Because there are engineering things, environmental things, architectural things, that we have to do, that once that train leaves the station, we may not be able to uncheck the box, to check our boxes, and dot the i's and cross the t's.
- -So please let us know as early as you can in the process, so that we can have the chance to come to the table, and give us a right of refusal for those different projects and the things that you're doing.
- -I appreciate and understand the role and responsibility of County Commissioners and City Council members and I thank you very much for what you do and for your service.
- -That concludes my presentation for this evening but I certainly will entertain any questions.

#### Chairman Bullard, stated the following:

-Thank you Mr. Speight, we appreciate what you do to help Columbus County and as you can see, everyone is always looking for extra help for the community through the representation we have here tonight.

#### Commissioner McDowell, stated the following:

- -Thank you for being here.
- -I think you partially answered my question in your final comments when you mentioned "come early".
- -My question was, with 15 persistent poverty counties, is there a formula used to try and assist all of those counties?
- -If so, to what degree would it be?

- -If not, if we were to have 5 major needs in Columbus County, would there be the possibility of having all those funded or is there going to be some type of quota or formula that's used to determine how much will be spent and where?
- -So, all of the 15 counties will have an opportunity.

#### State Director Reginald Speight, stated the following:

- -That's a great question Commissioner and let me know if I don't answer all of your questions.
- -There is not a pecking order and there is not a priority ranking for the persistent poverty counties and the work that we're doing.
- -As you can well imagine, and what I have already picked up by being in this room with you, is that not all persistent poverty counties are equal.
- -Some are more ready and able to come to the table to partner with us and we are not going to slow our efforts or wait due to that fact.
- -To answer your question specifically, if there is a way for you to participate in all 50 programs in USDA Rural Development, you could.
- -Right at this moment, money is not a problem, for whatever reason now.
- -With that being the case, there is also the opportunity for states that overproduce, and North Carolina is a higher producing state, on par with California or Texas.
- -So we are a higher-producing state.
- -I have no issue whatsoever, if we spend all the money in Columbus County, going back to the government and saying I need more money.
- -So, whatever the issues are, whatever it is we need to talk about more in detail at any particular time, we're willing to have those conversations.
- -As many projects that are feasible and affordable for Columbus County we will do them.

#### Chadbourn Councilmember Rashad Roberts, stated the following:

- -We have 2 other councilmembers here, as well as our Manager/Finance Clerk Ms. Patricia Gerald.
- -Thank you all for holding this event and thank you for taking the time to come here and speak.
- -Don't let this room fool you, there are people in this county that are hurting.
- -We might not qualify for all 50 programs but we're going to try.
- -So, please, remember our names, remember our faces whenever a decision is being made, and I might need to talk with Mr. Sampson, no disrespect to you, whenever we reach out.
- -Because we have a lot that is needed, when it comes to housing, infrastructure, broadband, not only in our towns but our ETJ as well.
- -Once again thank you for coming here this evening.

#### State Director Reginald Speight, stated the following:

- -Thank you Mr. Councilman.
- -And, let me say once again, I'm very familiar with rural.
- -Everything is a need and everything is a priority, I get that.
- -I'm thankful that I've been placed in this position for this appointed time to understand that that's the case.
- -I will be back, but Mr. Larry Sampson is an excellent person and an excellent resource to have here in this particular region.
- -Larry has dabbled in pretty much every program that we have, but at the same time do not hesitate to call me.
- -I know you have a good relationship with our Lumberton Office, but don't ever hesitate to call me.
- -I'll be happy to come back at any time.
- -I told people up the latter that my goal is to get to all 100 counties in the state of North Carolina.
- -If there's ever anything we can do, please, as I said, use us as a tool in your toolbox because we have a lot of opportunities there but only if we can make it make sense for you.
- -Because, as I said we have a loan/grant portfolio, so there are some programs that will require some local skin in the game, and there may be some opportunities out there that are 100% grant, because we've seen some of those things before.
- -I will get those things in your space as quickly as I can, so that you can at least digest it to determine whether or not there's something worth your pursuing.
- -Just know that you have an advocate and an ally in Rural Development.

#### County Manager Eddie Madden, stated the following:

- -First I just want to acknowledge the Lumberton Office staff, Mr. Larry Sampson and I go way back, and I've worked on a number of projects with Larry and others out of that office and it's a fantastic group of people.
- -A lot of your programs we've discussed have poverty-level criteria.
- -My understanding of a lot of the Rural Development programs is there is area-wide criteria and then there's site specific criteria.
- -You've mentioned a number of towns in Columbus County that meet your criteria.
- -Does that mean that, regardless of the location, as long as the application is for the benefit of a project inside of Columbus County, that it would meet that criteria or do we have to be specific to the towns you mentioned.

#### State Director Reginald Speight, stated the following:

- -We're still, and correct me if I'm wrong Larry, it's still going to be specific depending upon the program.
- -In the overlay that I did before, typically persistent poverty counties that the county as a whole qualify, but we do still go by the address or specific sites or what have you.
- -Some of these places may not meet criteria but areas around them may and then we can start looking at specific projects/programs.
- -The easiest thing to get off the ground, would be something that we do in housing.
- -Trying to do some things with individuals who want to purchase housing or housing rehab.
- -Your larger projects, requiring the environmental, the architectural, the engineering type things, such as water or broadband, it takes a little bit more time.

#### County Manager Eddie Madden, stated the following:

- -I know you mentioned a number of infrastructure projects that qualify and one was clean water
- -How about storm water?
- -Because it's a major concern for us here.

#### State Director Reginald Speight, stated the following:

- -There are some conversations that we're having with the Secretary's Office, my colleagues throughout the country, and the territories are that persistent poverty counties are persistent poverty counties for a reason.
- -They are the counties that can benefit from our programs the most, that can at least afford to come to the table to participate.
- -We have to talk about some special rule-making or some special projects to get you to the starting line.
- -And let's have those conversations, even if there is a set aside for persistent poverty counties, if we're serious, doing a set aside for persistent poverty counties only.
- -That some of the different criteria or things set up for eligibility can be eliminated to get you to the table that can at least be a catalyst for something else for the county.
- -Because water, waste-water, storm water, is something that, if that happens in the county, that changes things and I understand that.
- -And that starts you on a track where you no longer need Rural Development and you don't qualify for us.
- -That's what we want to do, get to that point, but sometimes there has to be special rule-making, so that those things can be eliminated, regardless of the median household income, regardless of the population, regardless of whether you're contiguous to another larger entity.
- -That we can get some work done, that circumvents some of those rules with special rule-making; and that is some of the conversations we're having up the chain and we're having some traction.

#### County Manager Eddie Madden, stated the following:

- -Finally, and I'll wrap up, you mentioned the key word "grant".
- -I'm assuming and I know in years past with USDA, depending on availability of funding, you could have less grant and more loan, and then other times more grant and less loan.
- -I'm hoping that more grant would be available during this round of funding than in years past.

#### **State Director Reginald Speight**, stated the following:

-It is my understanding that in this infrastructure bill there will be some robust grant opportunities available.

#### City Manager Darren Currie, stated the following:

- -I'm Darren Currie, City Manager for the town of Whiteville.
- -If there are loans available, what is the ballpark, and I know it depends on a lot of things, but what are some of the ballpark interest rates you're seeing right now?

#### Rural Development Area Director Larry Sampson, stated the following:

- -I believe we're at 2.25%.
- -I know that they are getting ready to increase that, and it will probably change with the next quarter, so after June 30<sup>th</sup>, but right now I believe we're still at 2.25%.

#### **INDEMNITY AGREEMENT**

**THIS INDEMNITY AGREEMENT** (the "Agreement") is made and entered into as of \_\_\_\_\_\_, (the "Effective Date") by and between COLUMBUS COUNTY, 127 W. Webster Street, Whiteville, NC 28472 (the "Indemnifier") and PG (MULTI-16), LP, a Delaware Limited Partnership registered to do business in the State of North Carolina, 50 Rockefeller Plaza, 2<sup>nd</sup> Fl., New York, New York 10020 (the "Indemnitee").

#### **BACKGROUND:**

- 1. The Indemnitee desires protection against any personal liability, claim, suit, action, loss or damage that may result from the Indemnitee's participation in the Activity.
- 2. The Indemnifier wishes to minimize any hardship the Indemnitee might suffer as the result of any personal liability, claim, suit, action, loss or damage that may result from the Indemnitee's participation in the Activity.

**IN CONSIDERATION** and as a condition of the Indemnifier and the Indemnitee entering into this Agreement and other valuable consideration, the receipt and sufficiency of which consideration is acknowledged, the Indemnifier and the Indemnitee agree as follows:

#### **Definitions**

- 1. The following definitions apply in the Agreement:
  - a. "Activity" means the following:
     Any lawsuit or transaction involving the Building Reuse grant in the amount of \$200,000 for Pipeline Plastics.
  - b. "Expenses" means all costs incurred in the defense of any claim or action brought against the Indemnitee including attorneys' fees.
  - c. "Notice of Claim" means a notice that has been provided by the Indemnitee to the Indemnifier describing a claim or action that has or is being brought against the Indemnitee by a Third Party.

- d. "Notice of Indemnity" means a notice that has been provided by the Indemnitee to the Indemnifier describing an amount owing under this Agreement by the Indemnifier to the Indemnitee
- e. "Parties" means both the Indemnitee and the Indemnifier.
- f. "Party" means either the Indemnitee or the Indemnifier.
- g. "Third Party" means any person other than the Indemnitee and the Indemnifier.

#### **Indemnification**

- 2. The Indemnifier will hold harmless and indemnify the Indemnitee against any and all claims and actions arising out of the participation of the Indemnitee in the Activity, including, without limitation, Expenses, judgments, fines, settlements and other amounts actually and reasonably incurred in connection with any liability, suit, action, loss, or damage arising or resulting from the Indemnitee's participation in the Activity, subject to the limits on indemnification described in the section titled Exceptions to Indemnification. Where prohibited by law, the above indemnification does not include indemnification of the Indemnitee against a claim caused by the negligence or fault of the Indemnitee, its agent or employee, or any Third Party under the control or supervision of the Indemnitee, other than the Indemnifier or its agent, employee or subcontractors.
- 3. In the case of a criminal proceeding, the Indemnitee will not be indemnified by the Indemnifier.

#### **Exceptions to Indemnification**

- 4. The Indemnitee will not be entitled to indemnification from the Indemnifier for any Expenses, judgments, fines, settlements and other amounts incurred as a result of the Indemnitee's participation in the Activity where:
  - a. in the case of a civil claim, the Indemnitee did not act in good faith and in a reasonable manner;
  - b. the claim or action is of a criminal nature;
  - c. the actions or conduct of the Indemnitee constituted willful misconduct or was knowingly fraudulent or deliberately dishonest;
  - d. the Indemnitee will or has received payment under a valid and collectible insurance policy or under a valid or enforceable indemnity clause, bylaw or agreement, except where payment under this insurance policy, clause, bylaw or agreement is not sufficient to fully indemnify the Indemnitee in which case the Indemnifier will be responsible for any shortfall in payment received; or
  - e. an action or proceeding was initiated in whole or in part by the Indemnitee whether alone or along with one or more other claimants unless the action or proceeding has the written consent of the Indemnifier.

#### **Notice of Claim**

5. In the event of any claim or action, the Indemnitee will promptly provide the Indemnifier with written notice of the claim or action and will notify the Indemnifier within five (5) business days of the commencement of any legal proceeding relating to the claim or action. The Indemnitee will provide the Indemnifier with all available information known to the Indemnitee relating to the claim of action.

#### **Authorization of Indemnification**

- 6. In any case where the Indemnitee requires indemnification, the Indemnifier will make the determination of whether indemnification is appropriate having given consideration to the terms described in the Exceptions to Indemnification section. If the Indemnitee disagrees with the determination of the Indemnifier then the matter must be referred for review and determination to independent legal counsel reasonably satisfactory to the Indemnitee. In all cases the Indemnifier will bear all costs of any independent determination.
- 7. The Indemnifier will bear the burden of proving that indemnification is not appropriate.
- 8. The termination of any claim or action by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent will not, of itself, create a presumption that the person did not act in good faith and in a reasonable manner.

#### **Assumption of Defense**

- 9. On being notified of any impending action or claim, the Indemnifier may, at its own Expense, participate in the defense of any action or claim and may, alone or with any other indemnifying party, assume the defense against the action or claim using counsel that are reasonably satisfactory to the Indemnitee.
- 10. Once the Indemnifier has notified the Indemnitee of the intention to assume the defense, the Indemnifier will no longer be liable to the Indemnitee for any further legal or other Expenses subsequently incurred by the Indemnitee in relation to the defense of the claim. Once the Indemnifier provides notice to the Indemnitee that the defense of claim has been assumed by the Indemnifier, the Indemnitee may employ or continue to employ its own legal counsel. However, any fees or Expenses incurred by the Indemnitee

subsequent to the notice of assumption of defense by the Indemnifier will be the sole responsibility of the Indemnitee.

#### Failure to Defend

11. If the Indemnifier elects not to assume the defense against the claim or action then the Indemnitee may defend against any claim or action in any manner the Indemnitee deems appropriate. The Indemnifier will promptly reimburse the Indemnitee for Expenses, judgments, fines, settlements and any other amounts actually and reasonably incurred in connection with the defense of the claim or action, subject to the limits on indemnification described in the section titled Exceptions to Indemnification.

#### Settlement and Consent of Indemnifier

12. The Indemnitee will not settle any claim or action without first obtaining the written consent of the Indemnifier. The Indemnifier will not be liable for nay amounts paid in settlement of any claim or action where written consent of the Indemnifier was not first obtained. The Indemnifier will not unreasonably withhold consent to any settlement.

#### **Settlement and Consent of Indemnitee**

13. The Indemnifier will not settle any claim or action without first obtaining the written consent of the Indemnitee. The Indemnitee will not unreasonably withhold consent to any settlement.

#### **Cooperation**

- 14. The Indemnifier agrees to cooperate in good faith and use best efforts to ensure that the Indemnitee is indemnified and reimbursed for any and all Expenses, judgments, fines, settlements and other amounts actually and reasonably incurred in connection with the defense of any claim or action resulting from the participation of the Indemnitee in the Activity.
- 15. The Indemnitee agrees to cooperate in good faith and provide any and all information within the Indemnitee's power as required for the defense of any claim or action and also to provide any and all information within the Indemnitee's power as required to help in a determination of indemnification as described under the Authorization of Indemnification section.

#### **Expenses**

- 16. No costs, charges or Expenses for which indemnity will be sought under this Agreement may be incurred without the Indemnifier's written consent. Any required consent must not be unreasonably withheld.
- 17. All reasonable Expenses incurred by the Indemnitee to enforce this Agreement, and all costs of defending any Third Party claims or actions brought against the Indemnitee under this Agreement, will be the sole responsibility of the Indemnifier subject to the limits on indemnification described in the section titled Exception to Indemnification.

#### **Advances of Expenses**

- 18. At the written request of the Indemnitee, the Indemnifier will advance to the Indemnitee any Expenses, including attorneys' fees, incurred by the Indemnitee in defending any action brought against the Indemnitee. Where reasonable, and to minimize hardship to the Indemnitee, advance payments may be made prior to the disposition of any claim.
- 19. The Indemnitee agrees to repay to the Indemnifier any advance payment on Expenses where a determination is ultimately made that the Indemnitee's behavior is not entitled to indemnification for reasons described under the Exceptions to Indemnification.

#### **Payment**

- 20. All payments made by the Indemnifier to the Indemnitee will be made in full in immediately available funds within sixty (60) days of receipt of Notice of Indemnity from the Indemnitee and without deduction for any counterclaim, defense, recoupment, or set-off.
- 21. Any Notice of Indemnity sent by the Indemnitee to the Indemnifier must be made in writing and contain a full listing of the items to be covered in the payment. Any payment made by the Indemnifier to the Indemnitee will contain a listing of items covered under the payment.

#### **Enforcement**

22. If any right or remedy claimed by the Indemnitee under this Agreement is denied or is not paid by the Indemnifier, or on its behalf, within sixty (60) days after a written Notice of Indemnity has been submitted by the Indemnitee to the Indemnifier, the Indemnitee may then bring suit against the Indemnifier to recover any unpaid amounts and, if successful in whole or in part, the Indemnitee will be entitled to be paid any and all costs related to resolving the claim.

23. Where a determination as described under Authorization of Indemnification concludes that the Indemnitee's behavior is not entitled to indemnification, this will not create a presumption that the Indemnitee is not entitled to indemnification under this Agreement.

#### Insurance

24. The Indemnifier, at its sole discretion, will make the good faith determination whether or not it is reasonable for the Indemnifier to obtain liability insurance against its potential liability in protecting the Indemnitee under this Agreement. The Indemnifier will select an insurer with a reliable reputation and, among other considerations, will weigh the costs of obtaining this insurance coverage against the protection afforded by this coverage.

#### **Duration**

- 25. The rights and obligations of the Indemnitee and the Indemnifier under this Agreement will continue:
  - a. so long as the Indemnitee is or will be subject to any possible claim or threatened, pending or completed action, suit or proceeding, whether civil, arbitrational, administrative or investigative that results from the participation of the Indemnitee in the Activity; or
  - b. until terminated by an agreement in writing signed by both the Indemnitee and the Indemnifier.

#### **Unlimited Indemnification**

26. Under this Agreement, indemnification will be limited to \$200,000.

#### Full Release

27. Only payment and satisfaction in full of all amounts and charges payable under this Agreement and the due performance and observance of all terms, covenants and conditions of this Agreement will release the Indemnifier and the Indemnitee of their obligations under this Agreement.

#### **Further Action**

28. No action or proceeding brought or instituted under this Agreement, and no recovery from that action or proceeding, will be a bar or defense to any further action or proceeding which may be brought under this Agreement by reason of any further failure in the performance and observance of the terms, covenants and conditions of this Agreement.

#### **Subrogation**

In the event that any indemnity payment is made under this Agreement, the Indemnifier will be subrogated to the extent of this payment to all of the rights of recovery of the Indemnitee. The Indemnitee will take all action required and provide all information necessary to secure these rights and to fully enable the Indemnifier to take any action to enforce these rights in the recovery of the indemnity payment.

#### **Amendments**

30. This Agreement may only be amended, terminated or cancelled by an instrument in writing, signed by both the Indemnifier and the Indemnitee.

#### **Assignment of Indemnifier's Rights and Obligations**

31. The rights and obligations of the Indemnifier as existing under this Agreement may not be assigned, in whole or in part, without the prior written consent of the Indemnitee.

#### Assignment of Indemnitee's Rights and Obligations

32. The rights and obligations of the Indemnitee as existing under this Agreement may not be assigned, in whole or in part, without the prior written consent of the Indemnifier.

#### **Joint and Several Liability**

33. If two or more persons act as Indemnifier in this Agreement or if the Indemnifier is a partnership consisting of two or more partners, then the liability under this Agreement will be joint and several for each co-Indemnifier.

#### **Notices**

34. Any notices or deliveries required in the performance of this Agreement will be deemed completed when hand-delivered, delivered by agent, or seven (7) days after being placed in the post, postage prepaid, to the Parties to this Agreement at the addresses contained in this Agreement or as the Parties may later designate in writing.

#### **Governing Law**

35. This Agreement will be governed by and construed in accordance with the laws of the State of North Carolina.

#### Jurisdiction

The courts of the State of North Carolina are to have jurisdiction to decide and settle any dispute or claim arising out of or in connection with this Agreement.

#### **General Provisions**

- 37. This Agreement contains all terms and conditions agreed to by the Indemnifier and the Indemnitee. Statements or representations which may have been made by either Party in the negotiation stages of this Agreement may in some way be inconsistent with this final written Agreement. All such statements are declared to be of no value to either Party. Only the written terms of this Agreement will bind the Parties.
- 38. Any failure of either Party to enforce any of the terms, covenants and conditions in this Agreement does not infer or permit a further waiver of that or any other right or benefit under this Agreement. A waiver by one Party of any right or benefit provided in this Agreement does not infer or permit a waiver of that right or benefit, nor does it infer or permit a waiver of any other right or benefit provided in this Agreement.
- 39. This Agreement will pass to the benefit of and be binding upon the Parties' respective heirs, executors, administrators, successors and permitted assigns.
- 40. The clauses, paragraphs and subparagraphs contained in this Agreement are intended to be read and construed independently of each other. If any part of this Agreement is held to be invalid, this invalidity will not affect the operation of any other part of this Agreement.
- 41. All of the rights, remedies and benefits provided in this Agreement will be cumulative and will not be exclusive of any other such rights, remedies and benefits allowed by law or equity that the Parties may have now or may acquire in the future.
- 42. Time is of the essence in this Agreement.
- 43. This Agreement may be executed in any number of counterparts, each of which will be deemed to be an original and all of which together will be deemed to be one and the same instrument.
- 44. Headings are inserted for the convenience of the Parties only and are not to be considered when interpreting this Agreement. Words in the singular mean and include the plural and vice versa. Words in the masculine gender mean and include the feminine gender and vice versa.

#### **Agenda Item #12:** DSS MONTHLY ADMINISTRATIVE UPDATE:

Algernon McKenzie, Director, provided the Board with the monthly update.

Monthly Administrative Update For March 2022 April 18, 2022 Meeting

March was National Social Work Appreciation Month. To celebrate the social work staff in our agency a luncheon was prepared and certifications of service in social work were presented to staff. The luncheon was sponsored by the social worker supervisors, social work program manager, and I. Hats off to our social work staff.

On March 10, 2022, I participated on the North Carolina Director's Association zoom meeting. During the meeting we received updates on Medicaid plans for Foster Children and Food & Nutrition. The state is continuing to work on the specialty Foster Care plan to ensure that children on foster care receive the proper services and coverage under Medicaid. This is an ongoing process.

We were informed that the state has requested an extension of the emergency Food & Nutrition Benefit payments, (\$95.00) that will end in April 2022. Therefore, these supplemental benefits could continue with USDA approval. If the extension is not approved families will continue to receive their regular benefits. We were also informed that families who are receiving TANF, Temporary Assistance for Needy Families will be getting an additional \$500.00 in the month of March for each child age 0 to 17 in the household. This payment is to assist families with the purchase of school supplies, clothes, etc. Funding for these additional payments are Pandemic Emergency Assistance Funds.

On March 16, 2022, the child welfare supervisors, social work program manager and I participated in a focus group. This focus group was led by a member of the ACT Team and the purpose was to identify gaps and needs in services to families affected by opioids. This team is working with the county to develop a plan to use the funds that are coming to Columbus County via the Opioid Settlement.

On March 29, 2022, we met with our child welfare representative to conduct our monthly check-in and review our program improvement plan. The supervisors, program manager, and child welfare staff have worked hard and have completed the requirements of our continuous quality improvement plan.

During the month of March there were two child fatalities. Both were teenagers and the deaths were reported to the state as required.

We lost one adult ward in March and had one adult's competency restored.

Lastly, I participated in ten webinars, zoom meetings, and in person meetings.

HUMAN SERVICES BOARD REPORT Melinda H. Lane, Program Manager Vacancies/Updates/News for March 2022

#### **Intake/Investigation/Assessment:**

The Intake/Investigation/Assessment Unit continues to be fully staffed. This Unit continues to be very busy with referrals involving substance abuse, domestic violence, and mental health issues, among other things. The Regional Child Welfare Consultant (RCWC) continues to make monthly contacts to review agency data, policy updates, and casework. This Supervisor recently met with staff from the Sheriff's Department along with the Program Manager and Director to discuss strategies to hopefully promote working together in a more positive manner. This Unit recently celebrated Social Work Month and will recognize Child Abuse Prevention Month in April.

#### **In-Home Services:**

The In-Home Services Unit continues to be short staffed due to a lateral transfer to another Unit, but interviews have been completed and a person has been recommended who will start in early April. Total contacts and children served continue to increase indicating more intensive involvement with current caseloads. The Regional Child Welfare Consultant (RCWC) continues to make monthly contacts to review agency data, policy

updates, and casework. This Unit recently celebrated Social Work Month and will recognize Child Abuse Prevention Month in April.

#### **Foster Care/Permanency Planning:**

The Foster Care Unit continues to be fully staffed. This Unit continues to break county records for the largest amount of children in custody in Columbus County. However, with a change in judge and a new DSS attorney who has a goal of working on dealing with this increase, caseloads are slowing beginning to decrease. Drug abuse, sexual abuse, and severe neglect appear to be the biggest contributing factors, along with a lack of family support. The Regional Child Welfare Consultant (RCWC) continues to make monthly contacts to review agency data, policy updates, and casework

This Unit recently celebrated Social Work Month and will recognize Child Abuse Prevention Month in April.

#### **Transitional Unit:**

The Transitional unit continues to be fully staffed. Staff continue to work caseloads while assisting the other Child Welfare Units as needed, particularly in the areas of courtesy requests from other counties and assisting with supervising visits and transporting children in custody. This Unit is helping particularly in the area of making monthly contacts with the large amount of children in foster care. Foster Home Licensing continues to work on completing more licensures to help increase the number of foster home available for the large amount of foster children. A new MAPP training began the last week of March and hopefully a good group of foster parents will come out of this training. Increasing foster care rates are projected to cause a bigger financial burden on counties that already have difficulty finding appropriate placements for children, especially those with behavior issues. The Regional Child Welfare Consultant (RCWC) continues to make monthly contacts to review agency data, policy updates, and casework. This Unit recently celebrated Social Work Month and will recognize Child Abuse Prevention Month in April.

#### **Adult Services:**

The Adult Services Unit currently has one vacancy, with a new hire coming into the other vacancy. This is the closet to being fully staffed this Unit has been in several months. The Supervisor continues to assist with making contacts with clients to assist her limited staff. This Unit continues to be busy in its day-to-day activities of contacts with the elderly and disabled and resource agencies. This can be a difficult population to work with at times because of their various needs, the lack of resources, and the adult's right to self-determination. A lack of appropriate placements for those adults with mental health issues also creates a huge burden on the county. This Unit recently celebrated Social Work Month.

#### **Work First Employment:**

This Unit continues to be fully staffed. Although this unit is open for in-person applications, telephone interviews continue for Work First applications, recertification's, short-term services and benefits. Certain necessary application documentation can be mailed to individuals that wish to apply and when received back the worker can conduct telephone interviews to complete that application. Some application information is also being provided for pick-up in the foyer area of the agency. Workers are encouraged to make telephone contacts with clients at least every two weeks to offer support and resources to clients. Transitioning back to regular application and case processing is now beginning after COVID-19 waivers end. This Unit recently celebrated Social Work Month.

#### **Child Day Care:**

The Child Day Care Unit is now fully staffed. The Supervisor and staff continue to work the over and under payment report to ensure proper payment is being made to county daycare providers. Day Care services are continuing to be provided and the state is working with county agencies and day cares to help them stay open as much as possible while providing a safe environment for children. Day Care slots within local Day Cares are limited at this time. DSS staff continue to work with families to ensure their services stay in place while limiting contact to the telephone as much as possible. This Unit is continuing to work on its waiting list to determine the continued need for services, which is decreasing slowly. Hopefully this will give the Unit a better idea of where the need is and decrease the waiting list.

#### **Program Integrity:**

Program Integrity now has a vacancy after the retirement of one of its staff. Interviews are scheduled. Office visits are limited and telephone contact is encouraged, but office visits are possible. Repayment agreements are being relaxed to help clients during this time. Staff are working to clean up a backlog, establishing cases and repayment agreements, all while assisting with the Energy Programs.

#### **Energy Assistance**

LIEAP and heating season ended March 31. CIP continues now with the cooling season which means helping with electricity needs. Applications continue to be available on EPASS where applicants can complete and submit applications on-line, but continue to be available in our lobby for pick up and completion. One in-house staff

person is currently processing applications and Program Integrity staff are assisting as needed. The one temporary staff person recently quit and there is discussion about getting another temporary staff person to assist, mainly due to the possible increase in Duke Energy Progress applications. Duke Energy Progress ended its moratorium March 31 and will now begin sending out disconnect notices. Customers received letters in March explaining this and encouraging customers to plan to talk with Duke about making a payment plan for past due balances to help alleviate disconnections. Many customers have paid very little, if anything, on their bills over the past several months leaving many with bills over \$1000. There is discussion by the state about the possibility of more supplemental payments and/or automatic approvals and more assistance from Duke Energy for its customers.

#### **Low Income Household Water Assistance Program (LIHWAP)**

LIHWAP continues for all counties. This program is a federally funded program that will provide emergency assistance to low-income households to prevent disconnection or provide assistance with the reconnection of drinking and wastewater services. It will be based on a priority list: Group 1 will consist of households that have had water services disconnected. Group 2 will consist of households that are in jeopardy of water services being disconnected unless action is taken to prevent the disconnect. Group 3 will consist of households that have current water service bills and need assistance to maintain service. We continue to work this program, assisting almost all applicants that submit applications for assistance. The majority of this allotment has been spent and there is discussion at the state level of more funding.

#### News/Updates/Vacancies

#### **Food and Nutrition:**

Results for our Audit with Food and Nutrition were found to be technical errors with no eligibility errors. With these Audits, there are no county chargebacks however USDA states if ONE error whether technical or eligibility is found, the county will have to complete a Corrective Action Plan. We are in the process of asking for a rebuttal on a few errors that were cited. The waiver for emergency allotments for households are being requested and approved on a monthly basis. The other waivers that have been put in place have been extended to June 30, 2022. The State has indicated they will notify counties 60 days prior to the termination of the Public Health Emergency. Once the PHE ends, the flexibility of the majority of waivers will end at the end of the month following the month in which the Public Health Emergency ends. The State has developed a Guidebook to help plan for the transition back to regular processes after the waivers end and is intended to assist counties in developing plans. There are currently 2 vacancies on this team with 1 new employee in training.

#### Adult and Family & Children's Medicaid:

The Medicaid Team failed their Monthly Report Card for timeliness last month due to misinterpreted policy on applications that come from the Marketplace. We have asked for a waiver since all staff and all applications that were involved included those coming through the Marketplace. All staff has been retrained and we are back on a timelier processing schedule. We continue to follow waivers until the Public Health Emergency has ended. The Adult Team still has 2 vacancies with 1 new hire in the early stages of training. The Family & Children's Medicaid Team has 2 vacancies and 2 in the early stages of training. One vacancy has been filled and the new employee will begin in April.

#### Medicaid for Long Term Care, Medicaid Transportation and Housekeeping:

- This Team has a new Supervisor in the Long Term Care unit who was a former employee with experience in this department. © This Team has 1 vacancy and 1 new hire with only 4 positions.
- Transportation continues to remain very busy with the cost of gas rising, a lot of those that receive Medicaid are eligible for transportation due to putting a financial strain on the family.
- Housekeeping continues to keep our building clean and we continue to have a vacancy on this team.

#### **Child Support and Paralegal:**

This Team continues to struggle to have applicants to choose from to interview for vacancies. With 3 court days, they prepared 197 cases for court and 196 orders were prepared by the paralegal. Workers are also struggling with getting cases to court and meeting timeframes due to 6 vacancies currently.

# COLUMBUS COUNTY, NORTH CAROLINA Ordinance amending appropriations to the Capital Project Fund for the Fiscal Year beginning July 1, 2021

BE IT ORDAINED by the Board of Commissioners of Columbus County, North Carolina as follows:

Section 1: The following amounts are hereby made to the Sheriff's Dept. – LESO Equipment Project pursuant to G.S. 159 -13.2 for the fiscal year beginning July 1, 2021.

Section 2: The project undertaken pursuant to this ordinance is in accordance with the Recommended Budget .

Section 3: The Finance Director is hereby directed to maintain within the Capital Project Fund sufficient specific detailed accounting records to satisfy all applicable regulations. The terms of any financing agreement also shall be met.

Section 4: The County desires to expend its own funds for the purpose of paying certain costs of various projects, for which expenditures the County reasonably expects to reimburse itself from the proceeds of debt to be incurred by the County.

Section 5: All expenditures relating to obtaining any bond referendum and or installment purchase will be reimbursed from bond proceeds and installment purchase proceeds in accordance with the requirements of the United States Treasury Regulations Section 1.150 -2.

Section 6: This declaration of official intent is made pursuant to Section 1.150-2 of the Treasury Regulations to expressly declare the official intent of the County to reimburse itself from the proceeds of debt to be hereinafter incurred by the County for certain expenditures paid by the County on or after the date which is sixty (60) days prior to the date hereof.

Section 7: The County intends to seek Federal, State, and/or other grant funding to reduce the amount of loan proceeds. The adoption of this ordinance authorizes the County Manager and/or his representative to apply for and accept such funding if awarded.

Section 8: This project ordinance shall be entered in the minutes of the Board of Commissioners of Columbus County. Within five days hereof, copies of this ordinance shall be filed with the finance office in Columbus County, and with the Clerk to the Board of Commissioners of Columbus County.

Capital Project amendment shall become effective on April 18, 2022.

Subject: Emergency Services Metal Building Construction Project

Through the assistance of NC State Representative Brenden Jones, Columbus County received an allocation of \$250,000 from the NC General Legislature for the construction of a county garage. As part of our planning process to ensure the county's critical emergency service resources are prepared and ready for service, a 100' X 60' metal building is planned to be constructed to house emergency services vehicles, trailers, and related equipment. This building will be also be utilized as a logistical warehouse with emergency backup power capabilities during natural disasters.

As part of the planning process, a needs assessment was conducted along with a review of potential site locations for the building. Ultimately it was decided the best location for the building would be in the fenced in area of the county's North Complex adjacent to the Public Utilities Department. This location provides several beneficial factors including security, loading dock access, and egress and storage for large shipping vehicles.

Bids were solicited for the various construction projects needs and below is the recommended budget for approval.

- -People need to get better work ethics and go back to work.
- -I know the pandemic's been bad and caused a lot of problems but it's time to put that behind us.
- -It's time to go back out and get a job and support your family, and do the best you can.
- -That helps the county.
- -I wouldn't come here looking for someone if they couldn't even get 24.
- -Why would I come looking for more?
- -I have a question: Who's over the vehicles, Mr. Madden?

#### County Manager Eddie Madden: Mr. West.

#### **Commissioner Byrd** stated the following:

- -Mr. West, I was out at Jack Ellis' Machine Shop last week and we have a county truck sitting there, it has county stickers on it and it's been there for a long, long time.
- -It needs to come back in the inventory or if it's not worth fixing it needs to be sold or something. **County Manager Eddie Madden:** We'll check into it.

#### 3. **Vice Chairman McMillian** stated the following:

#### 5. **Commissioner McDowell** stated the following:

- -I want to congratulate Mr. Speight and thank him for taking the time to come and make us aware of what we need to do to get grants.
- -Everything you read, talks about pandemic money, and I've said several times, we had a perfect storm, unfortunately, with the pandemic money coming in, as well as the opportunity to purchase a lot of property from Truist.
- -They were very community oriented.
- -So, it sounds to me that our challenge is to identify projects that we know we need, begin the paperwork, and get that stuff in to them as quickly as possible.
- -Five items were identified, five different ways to spend that money, and I was quite pleased that he mentioned Nakina, because certainly we could use more infrastructure, anyone could.
- -Because obviously, as everyone knows on this Board, and most of the public knows, that end of the county is going to grow substantially in the next few years.

- -I appreciate you Sheriff for what you've done and I appreciate the county for helping us get it down there, I really do, and the rest of the folks down there appreciate it too.
- -I think it's a big step forward for us.

#### 7. **Chairman Bullard** stated the following:

- -I'd like to say I hope everybody had a good Easter this weekend.
- -I appreciate what everybody is doing.
- -I'm hearing a lot of positive comments coming from different people about how pleased they are with everything that's going on in this County.
- -And I thank everybody who's playing a part in making it happen, thank you for what you're doing.
- -It means a lot to be a Commissioner and people are happy.
- -It makes you feel good and very proud of the county that you live and serve in.
- -It's good that there are open jobs in Columbus County because it lets you know there are opportunities for people.
- -So there is a good side, it's not all bad.
- -On the county's Facebook page, can we list businesses that have multiple openings?
- -Can we get a category to start helping businesses in Columbus County if they call the county and they say we're looking for someone, and help them advertise it?
- -Would that be possible?
- -Thank everybody for what you're doing.

#### **Commissioner Watts** stated the following:

- -I would like to ask Mr. McKenzie, back on this criteria, is your staff as strict as they can be?
- -Because, if it's somebody that can work, and we can't fill jobs, I mean, I know we've got to do what the law says but they need to be strict and make sure somebody's able to work and not getting something they don't deserve.

#### **Director Algernon McKenzie** stated the following:

- -There is criteria for the different programs we offer and we are audited on those items to make sure we follow that criteria.
- -People are able to request extensions and particularly on the welfare benefits, like the TANF program, you have to meet certain criteria to get an extension, but like I said, we are audited on all of those programs, and we follow the guidelines the government has put in place.
- -Some guidelines are stricter than others but all we can do is encourage folks to go to work; we even post things in our lounge area about jobs.

#### **Director Algernon McKenzie** stated the following:

-Yes, they're applications have to be signed off on.

#### B. County Manager Eddie Madden stated the following:

- -I appreciate everyone's time this evening.
- -We're in budget season and you all are aware of that; our staff certainly is.
- -This year is a slightly different year for us because of the additional step we must take to submit our preliminary budget to the Local Government Commission (LGC).
- -It has to be submitted to them by May 15<sup>th</sup>.
- -We had hoped to present the budget at the May 16<sup>th</sup> meeting but because the deadline to the LGC is on the 15<sup>th</sup>, we've had to step up our formal presentation to you to May 12<sup>th</sup> at 5:00 P.M.
- -So, we've called a special meeting for that presentation, at that stage it would be considered preliminary, and so the budget we would submit to the state would be preliminary and not final by any means.
- -And certainly not vetted by this Board at that point, but because of that LGC requirement and the deadline they've given us, we've asked you all to come together with us on May 12<sup>th</sup>, so we could go through the presentation with you and get your approval to submit it in the preliminary format to the Local Government Commission.
- -From there, and Mr. Leatherman help me please if I'm incorrect, the LGC will review the budget, and if they have any input, they will send it to us, prior to you holding your public hearings in June.
- -So, from around the 15<sup>th</sup> of May to the 1<sup>st</sup> of June, we anticipate getting feedback from the Local Government Commission.
- -That's why we're doing things a little bit out of the norm.
- -Not because of anything we've asked for but certainly, the Local Government Commission has.
- -So, we look forward to having you back on May 12<sup>th</sup>.

- -I want to highlight the resolution you all approved on tonight for The Wooten Company to present an application on behalf of the Town of Lake Waccamaw.
- -That is in accordance with the agreement that is in place with the County and the Town over the \$2.5 million dollars of state funds that are supposed to be set aside for the walking trail project at the Lake.
- -As you know, we entered into an agreement with the town that we would submit an application on their behalf for grant funding and if awarded we will have met our obligation.
- -Our project was \$2.5 million from the State.
- -The application that we are submitting on their behalf is for \$4.9 million dollars.
- -Since the Board approved that resolution this evening, the interconnect project that they requested, we are submitting it on their behalf.
- -I just wanted to update the Board.
- -The second floor renovations of this building are ongoing and drywall, for the most part, hung.
- -There will be work that will continue thereafter for mudding, taping, sanding and so forth, but significant progress is being made there.
- -I do want to point out the contributions being made by our staff.
- -I want to thank Stuart Carroll and the maintenance staff for their work as most of this is being taken care of in house and we're saving considerable dollars in doing so.
- -We appreciate their excellent work.
- -In keeping with those renovations, we anticipate moving the Tax Office sometime in the middle of May, so just a few weeks from now, which is slightly ahead of schedule.
- -This evening, as Commissioner McDowell pointed out, we did meet with the USDA State Director, Mr. Reginald Speight, to discuss funding opportunities for Columbus County, as well as all of our respective towns.
- -He listed those in detail, Whiteville, Boardman, Evergreen, Nakina and I believe one other that I missed.
- -We qualify for what's called their higher poverty rate category for persistent poverty.
- -Not a category you want to be in but for funding purposes, you definitely want to be in.
- -This opens the gateway for funding for capital projects, housing projects, rehab services for housing purposes, community facilities and business grants and loans.
- -I will tell you from experience that these programs are very useful but they have historically had significant strings attached.
- -The main one is on the rehabilitation program.
- -So, in the past, these funds have only been available for owner occupied dwellings, and it is a challenge for staff and our consultants to identify properties that qualify under the program, because of that restriction.
- -I'm very pleased that they were here this evening and we were able to communicate that to them, and hopefully as he indicated, there may be some flexibility in the offerings of some of these dollars to benefit not only owner-occupied dwellings but tenant occupied dwellings going forward.
- -The Chairman and I participated in a Ribbon Cutting last week for the new mobile crisis unit operated by Coastal Horizons and Trillium.
- -The unit will be manned by licensed professionals who will respond to calls for service for mental health as well as severe cases of addiction.
- -The main benefit of this unit is that it is truly mobile.
- -It will be accessible to the remote parts of our county, regardless of the location, and hopefully reduce the barriers that have been in place because of transportation limitations.
- -Last Thursday, I met with the Brunswick Electric Board of Directors and I provided them an update of our progress over the past year.
- -We discussed several ways to partner together on economic development projects, Dr. Lanier will be pleased to know that.
- -I was very, very encouraged by their interest in us, and they have indicated that many opportunities will be made available through those discussions in the coming months, so we're very encouraged by that.
- -The opioid task force will be meeting in the next few weeks to evaluate the process to delegate the settlement proceeds we will be receiving.
- -We were made aware last week that the first installment will be made available to us in the Spring of 2022.
- -They have not specified the date, but sometime this Spring, the first installment is \$302,095.00.
- -I believe the second installment is due sometime this Summer, for a total in the first year approaching the \$1-million-dollar mark.
- -The total amount to the county that we will receive is just over \$7 million dollars.
- -So, our work is before us to make sure that these funds are spent in the appropriate manner and as expeditiously as we possibly can.
- -I will be out of the office on Wednesday through Friday for a conference in Winston Salem.
- -The conference is the North Carolina Airports Association Annual Conference.

- -I will be checking email and responding to texts and phone calls, so feel free to reach out to me if you need me
- -At that meeting, I will be installed as the President-elect of the Association.
- -I've been serving on this Board for almost 8 years and will be assuming the President's role for the North Carolina Airport Association in July.
- -So, I just wanted to pass that along to you.

#### **Commissioner McDowell** stated the following:

-The Trillium mobile unit, is it only able to go out in the county or can it go anywhere, like the jail for example? When they have people who are arrested? And the Sherriff is shaking his head no, okay, I just thought that maybe that could be an asset.

#### **County Manager Eddie Madden** stated the following:

- -There's a hotline you call to activate that service and we've just been introduced to having this capability, that we have not had before.
- -It will have licensed professionals on board.
- -What they have said to us is that if the demand is greater than what they anticipate they will add additional resources in the future.
- -Maybe even a second mobile unit, but that remains to be seen.
